

TERMS and CONDITIONS for Workshops

These terms and conditions (the “Terms”) apply to all goods and services available through the website under the domain name www.jmmzenterprisesltd.com (the “Website”) and the registered business JMMZ Enterprises Ltd.

When purchasing any goods or services from JMMZ Enterprises Ltd the purchaser signifies their agreement to be bound by these terms.

1. Bookings and Payments

1.1 All bookings must be made through your bank to: FCB (First Citizen Bank)

1.2 JMMZ Enterprises Ltd will confirm a place in a class or workshop once payment has been confirmed.

2. Workshops

2.1 To secure a place in a workshop the fee must be paid in full in advance on 'a first in first served' basis.

2.2 All workshops are capped and JMMZ Enterprises Ltd reserves the right to modify the cap number as it is deemed necessary.

2.3 Workshops are held over 4 hours, with each day starting at 10:00 am and finishing at 2:00pm.

2.4 JMMZ Enterprises Ltd reserves the right to change the start and finishing times of workshops.

2.5 Any pre/paid workshop participant affected by such a change will be notified as soon as any change is made and if necessary offered another workshop time or a full refund, less the non-refundable administration fee outlined in clause 6.1, below

3. Participation

3.1 For the full JMMZ Enterprises Ltd experience in getting the most out of the 4-hour session participants are expected to be ready at the start time and duration of the workshop.

3.2 If participants arrive late or leave early they are expected to do so quietly causing minimal disturbance to the class. The tutor must be informed of any such arrangements or disturbances prior to the class starting.

4. Availability and information

4.1 JMMZ Enterprises Ltd endeavours to make as many classes and workshops available however reserve the right to vary the availability and information for classes as is deemed necessary.

5. Cancellation and refunds

5.1 Any requests or payment of refunds by JMMZ Enterprises Ltd will incur a TT\$50.00 administration fee.

5.2 Should a workshop need to be cancelled due to insufficient numbers, participants will be notified and either offered a similar workshop or a full refund, less the non-refundable administration fee.

5.3 Up to 7 days before a scheduled class or workshop JMMZ Enterprises Ltd will accept a cancellation and refund any payment, less the non-refundable administration fee.

5.4 From 6 days to 24 hours before a scheduled class or workshop JMMZ Enterprises Ltd will accept a cancellation and refund, less the non-refundable administration fee, at 70% of the remaining original payment.

5.5 In the 24-hour period before a scheduled class or workshop no refund is available.

5.6 JMMZ Enterprises Ltd reserves the right at any time to negotiate, change or vary the terms and conditions in clauses 6.1 to 6.6 above as it deems appropriate.

6. Recognition

6.1 JMMZ Enterprises Ltd is not a Registered Training Organisation and as such, courses are not accredited and are only available as non-vocational courses.

6.2 However JMMZ Enterprises Ltd does strive to deliver excellence in all workshops.

7. Safety and Cleanliness

7.1 Participants must adhere to all safety guidelines and instruction regarding the use of any materials and tools.

7.2 At the end of each workshop day participants are expected to clean their work area to a standard acceptable to the tutor

8. Privacy Policy

8.1 JMMZ Enterprises Ltd respects individual privacy.

8.2 Any information provided to JMMZ Enterprises Ltd for the purposes of obtaining goods and services from JMMZ Enterprises Ltd will be used for that purpose and any email address will be added to the JMMZ Enterprises Ltd email list.
